

## National Health Research Enterprise Doctoral Programme

### PhD Scholarships for Health Science Research

The National Health Research Enterprise (NHRE) Programme is an initiative of the South African Medical Research Council (SAMRC) to fill a gap left by the substantial reduction in international funding available to the South African health research ecosystem. The NHRE is supported by funding from the SAMRC, National Treasury, through the National Department of Health, Gates Foundation and Wellcome Trust. It is founded on a shared commitment to retaining the research infrastructure and high-calibre cadre of clinicians and scientists who have led pioneering research and innovation that has been impactful, not just for South Africa, but for the whole world. Maintaining this world class infrastructure and capacity relies on continuing to develop the next generation of health researchers through multidisciplinary, innovative doctoral training. The NHRE Doctoral Programme is a new initiative that aims to strengthen health research capacity in South Africa by supporting outstanding doctoral candidates undertaking innovative research that addresses priority health challenges.

Research areas of relevance include:

- HIV, TB and other infectious diseases
- Maternal, child and adolescent health
- Pandemic preparedness
- Non-communicable diseases
- Health systems and policy research
- Climate and health

Applications that also include cross-cutting technologies such as digital health, artificial intelligence and genomics are encouraged.

Successful candidates will be expected to conduct rigorous, relevant doctoral research under the supervision of experienced researchers; actively engage in structured mentorship; and participate in scientific engagement activities, thereby preparing them to become the next generation of leaders in health research. Interdisciplinary collaboration and industry-focused research are also encouraged.

The purpose of this Request for Applications (RFA) is to build a pipeline of highly skilled PhD graduates in the health sciences who will drive health research and innovation in South Africa and contribute to global health impact.

- 1) Must be a South African citizen or permanent resident.
- 2) Must hold a master's degree.
- 3) Must have a PhD research project that has been endorsed by the prospective supervisor and institution.
- 4) The proposed PhD research project must be within the health sciences, preferably with the potential to deliver meaningful health impact.
- 5) Must be registered as a full-time PhD student at a South African university at the commencement of the award.
- 6) Must provide a written commitment of participation from an appropriately experienced research supervisor who is willing to train the student for the entire duration of the degree.
- 7) The research supervisor must have research funding for the project and appropriate facilities for the scholar to effectively conduct the PhD research project.

Application steps 1 to 3 below must be completed before the specified deadlines.

- Step 1 – Applicant to complete the [online application](#) form **by 22 September 2026**.
- Step 2 – Applicant to upload all the required supporting documents **by 22 September 2026**.
- Step 3 – The research supervisor must complete the research supervisor's abridged track record and commitment form and submit the application on or before **29 September 2026**.

**Incomplete applications will not be considered.**

**The South African Medical Research Council reserves the right to disqualify ineligible, incomplete and/or inappropriate applications, change the conditions of the award, extend the closing date, or make no awards at all. Please note that only successful candidates will be contacted after completion of the review, selection, and approval processes. Should you not hear from the SAMRC by 31 December 2026, please assume that your application has been unsuccessful.**

### **Scholarship Conditions**

- Scholarship holders are expected to spend at least 80% of their time conducting research.
- Teaching and clinical activities may not take up more than 20% of the time of the scholar.
- Candidates may not hold a bursary from more than one South African Government statutory entity at any given time.
- Scholarship holders may not receive, concurrently with this scholarship, other bursaries, grants or remuneration which bind them to enter the service of any organization without prior agreement of the SAMRC.
- Scholarship holders may not receive, concurrently with this scholarship, other non-binding remuneration/scholarships/fellowships and grants without prior agreement of the SAMRC.
- Scholarship recipients will be required to declare the value of any other scholarship(s) or award(s), whether in cash or in-kind or direct payments into their personal bank accounts that they may hold for the same study programme.
- Scholarship holders may not, without seeking approval from the SAMRC, register at a university other than that through which the application has been submitted.
- Once the scholarship has been awarded, the scholarship holder may not change his/her supervisor without informing the SAMRC.
- Application for renewal of funding will be considered on an annual basis, and success thereof will be subject to satisfactory progress being made.
- Continuation of funding is subject to the submission of a satisfactory progress report from both student and supervisor.
- The scholarship is for the specified enrolment year and therefore cannot be deferred to subsequent years.
- Successful applicants will be required to sign acceptance of the SAMRC Scholarship terms and conditions.

### **Protection of Personal Information Act (POPIA)**
